5. Student Support and Progression

5.1 Contribution of IQAC in enhancing awareness about Student Support Services

The IQAC in consultation with the Governing Body and the Academic sub- committee sets out rules and regulations of the college annually. Students are informed through the prospectus, college website and notices about the various support services available in the college. Principal, senior teachers and staff members also address the students on the first day in college about various rules and regulations as well as facilities available to them. IQAC members along with the various subcommittees monitor the teaching learning and other needs of the students. Special attention is paid to the disputations/problems through Anti Ragging cell and Internal Complaint cell. Student mentoring in groups has been initiated in laboratory based subjects. Psychological counselling and health clinic for students was organised on a weekly basis.

- Class tests, mid-term tests and test examinations are held regularly.
- Slow learners are provided with remedial classes. Special attention is paid to slow learners from underprivileged backgrounds, like SC, ST and OBC.
- Departmental meetings are held regularly to assess the students' progress and the authority is informed accordingly.
- Parent –teachers meetings are held by the Departments regularly. Guardians of students with inadequate attendance are called upon and informed accordingly. All these efforts are carried out under the leadership of the IQAC through the Academic sub-committee and HODs.
- Student seminars are organised regularly to enrich their outlook and communicative skill.

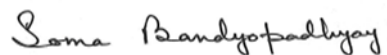

BEST PRACTICE I-

Title: Installation of Environmental monitoring system for airborne allergenic fungal spores & pollen grains in Howrah city

Objective

To conduct a continuous qualitative & quantitative monitoring of airborne bio particles (fungal spores and pollen grains) in the industrial area of Howrah city and to assess their potential to induce respiratory allergy and asthma in susceptible local industrial suffering from respiratory disorders.

Context

Airborne suspended particles often cause different kinds of respiratory problems upon inhalation. In addition to inorganic particles, there are varieties of particles having biological origin, which become airborne. Among airborne bioparticles, pollen grains and fungal spores are important trigger to induce respiratory and allergic asthma, lung infection, allergic sinusitis, rhinitis, conjunctivitis, etc. Hence these are termed as environmental biopollutants.

According to World Allergy Organization, 400 million world population suffer from allergic rhinitis and 350 million from bronchial asthma. The rate of increase in respiratory allergy and asthma is too rapid for the change in human genetic pool. Hence it has been suggested that this increase may be primarily due to increased exposure level to airborne allergens. In a survey of national burdens of disease in Indian population, it was reported that more than one-third (34%) ‘sick days’ were caused by allergic rhinitis and asthma, especially in cities. About 15–20 million asthmatic patients live in India and the number increases rapidly with industrialization.

The study is being conducted in Howrah, the twin city of Kolkata on the west bank of Hoogli river, and the second largest city of West Bengal. The railway station of this million-plus industrial city serves as a terminal of Eastern and South Eastern Railways, connecting Kolkata-Howrah to other parts of country through its vast network of tracks. The railway regularly unloads thousands of migrants, who eventually settle down in the numerous slums and unauthorized settlements, resulting into steep population rise. Often termed ‘Sheffield of the East’, Howrah is one of the most important industrial hubs, mainly for light engineering industry and others. It is estimated that 20% of the population of Howrah lives in slums and unauthorized settlements with remarkably unhygienic and polluted environment.

There is no record of the effect of airborne biopollutants on respiratory health of the people in this city till date. A comprehensive and correlative study of airborne allergenic pollen and fungal spores of this city will provide valuable and useful data for environmental policy-makers

and health-care providers serving the asthmatics of the world's one of the most populated country.

Practice

Continuous monitoring of atmospheric bioparticles (pollen and spores) is conducted with a 7-Day recording Volumetric Sampler (Burkard Manufacturing Co., Hertfordshire, United Kingdom). The device has been installed in college to provide continuous hourly airborne pollen-spore record. The data will be useful to assess the exact level of pollen-spore exposure, which have the potential to induce allergic problems and asthma.

Success Indicator

The management of respiratory allergy/asthma depends on two factors – avoidance of exposure and therapy. In this respect, avoidance is the best measure. To do this, awareness development about allergen particle exposure is very important. Regarding this point of view, our mission to measure the bioparticle exposure level is appreciated by a number of people. Students are also inspired and they are the most energetic group to help in the awareness development in local population suffering from respiratory disorders.

Resources required

Environmental bioparticle exposure assessment for respiratory allergic population of an industrial area requires the involvement of academicians, researchers, medical experts, institutional co-operation, students' involvement and participation of local people. In the long run of time, along with the positive approach from all aspects, our mission will certainly be a success. There is already a preliminary collaboration with the Division of Plant biology, Bose Institute, Kolkata, at initial level. Further involvement of the scientists of West Bengal Pollution Control Board is included in the plan of near future.

Problems enquired

Except some technical problems regarding the export and instalment of the 7-day recording volumetric sampler, everything is perfectly alright until now.

ANNEXURE II
